

4 . First Aid Measures

6 . Accidental Release Measures

7 . Handling and Storage

7 . Handling and Storage

Storage Store in accordance with local regulations. 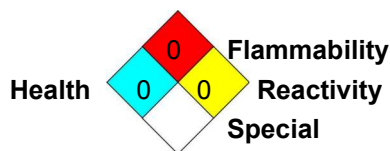

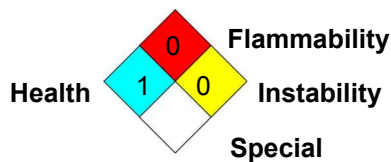
